## 2. Scope of Services

Proposals should address the following key service areas that are outlined in detail in the CID business plan:

# A. Safety and Security

- 24/7 patrols (vehicle and foot) across key areas.
- CCTV and License Plate Recognition (LPR) monitoring.
- Coordination with SAPS, City of Cape Town Law Enforcement, and private security.
- Implementation of crime-prevention measures.
- Monthly crime and incident reporting.

# **B.** Cleaning and Maintenance

- Daily street and sidewalk cleaning.
- Waste removal and coordination with municipal services.
- Drainage maintenance and graffiti removal.
- Maintenance of public infrastructure.
- Employment of local workers through social upliftment programs.

#### C. Parks and Recreation

- Rehabilitation and management of Jutland Park, Maynard Park, and Tuin Plein.
- Installation and maintenance of playgrounds, fitness areas, and gardens.
- Park security and management of green spaces.
- Organizing community events and park activities.

#### **D. Social Services**

- Dedicated full-time social worker.
- Assistance for homeless individuals in accessing social support services.
- Coordination with NGOs and government programs.

- Monthly audits of homelessness and by-law infringements.
- Employment and reintegration programs.

#### 3. Proposal Requirements

All submissions must include:

- Company Overview (including CID-related experience, if any).
- **Proposed CID Service Model** (approach, methodologies, and implementation plan).
- Organizational Structure (team roles, responsibilities, and scheduling format).
- Budget Proposal (operational and capital costs, with clear breakdowns).
- Performance Metrics (accountability framework and measurement of success).
- Compliance Confirmation (alignment with CID by-laws and municipal regulations).

## 4. Evaluation and Selection Process

The **Lower Gardens CID Steering Committee** will evaluate proposals based on:

- Alignment with the Business Plan and CID priorities.
- Experience in providing similar services, particularly within CIDs.
- Cost-effectiveness and sustainability of the proposed solution.
- Ability to meet performance-based targets and community engagement.

## **Shortlisting & Presentations:**

- Shortlisted suppliers will be invited for in-person presentations in April and May 2025.
- Final selection is contingent upon City of Cape Town Council approval (expected between May–June 2025).
- Earliest contract start date: 1 July 2025.
